RELEASE, INDEMNITY, AND LEGAL WAIVER

In consideration of being permitted to train and participate in the martial arts of Tae Kwon Do, Ju Jitsu and other arts (hereafter referred to as "martial arts") as taught, demonstrated, performed and executed by Plano Martial Arts, the releasor, for him/herself, spouse, legal representatives, heirs and assigns, hereby releases, waives and discharges Plano Martial Arts, its officers and employees, referred to as releasee, from all liability to the releasor, his/her spouse, legal representatives, heirs and assigns for any and all loss or damage, and any claims or damages resulting therefrom, on account of injury to releasor's person whether caused by negligence of releasee or otherwise while the releasor is participating in martial arts.

Releasor agrees to indemnify releasee from any loss, liability, damage or cost he/she may incur due to the presence of releasor in or upon the premises of Plano Martial Arts, whether caused by negligence of releasee or otherwise. Said indemnity shall inure to releasee on the occasion of martial arts testing and/or tournaments conducted off the premises of releasee.

Releasor further agrees to release from any claim whatsoever on account of first aid, medical treatment or services rendered during participation in martial arts and further agrees to waive claims against any person connected with any injuries which releasor may sustain and releasor likewise assumes full responsibility for his/her actions in connection with training and participating in martial arts.

Releasor expressly agrees that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
